The logo of the Quality Label was designed by children and further on, shared for potential use also in the wider European context.





 Child Safeguarding policies and procedures were developed in Greece and Romania, based on the international standards on safeguarding, on Keeping Children Safe coalition, UEFA toolkit & Terre des hommes. These standards were adapted to local legislation.

In Romania they benefit of the close involvement of the National Authority for the Protection of the Rights of the Child and Adoption (NAPCRA).

- Romanian Gymnastics Federation and Romanian Football Federation signed for the first time in Romania these policies and their public commitment was followed by another 20 sport clubs and associations from Ro.
- In Greece, 20 summer camps signed and committed to respect CSG policies and procedures.







### **Child Safeguarding Champions**

- 22 trainers in Romania
- 22 trainers in Greece
- 186 coaches trained in Romania football, gymnastics, handball, karate and other sports – 15 multiplication trainings in Bucharest, Deva, Cluj, Sibiu, Timisoara, Arges, Constanta, Focsani, Resita
- 170 summer camps staff in 7 multiplication trainings



### 7 steps towards developing and implementing a Child Safeguarding Policy



# STEP 1: ADVOCACY FOR INSTITUTIONAL COMMITMENT TO CHILD SAFEGUARDING

### <u>WHY?</u>

 Institutional support at the highest hierarchical level (e.g., sports federations and associations) is needed for ensuring a sustainable and meaningful impact.

### WHAT?

 Meetings and/or workshops on child protection and child safeguarding for decision-makers (e.g., presidents of the sports federations, sports clubs, and summer camps managers, State child protection authorities).





### **STEP 2: DEVELOPMENT OF THE CHILD SAFEGUARDING POLICY**

### <u>WHY?</u>

The **Child Safeguarding Policy (CSP)** explicitly defines the manner in which your organization contributes to keeping children safe. It includes all the preventative and responsive measures that you shall take to preserve children's safety and well-being in your activities.

- Find and study the relevant national legislation on child protection;
- Collaborate with a child protection organization/expert for the development of the Policy;
- Consider whether your organization already has an internal policy that foresees measures for the safeguarding of children;
- Include in the Child Safeguarding Policy the voices of the children you are working with.





# STEP 3: TRAINING THE STAFF ON CHILD PROTECTION AND CHILD SAFEGUARDING

### <u>WHY?</u>

Safeguarding is a multidimensional concept; it usually requires sustained effort in order to be fully reflected in your organization's procedures and practices.

- Peer-to-peer approach;
- Training of Trainers and replication trainings.





# STEP 4: DESIGNATING AND TRAINING A CHILD SAFEGUARDING FOCAL POINT

### <u>WHY?</u>

A **Child Safeguarding Focal Point** is the person responsible for monitoring and evaluating the implementation of your Child Safeguarding Policy, providing training to the staff, proposing its review when necessary, and managing concerns related to child safeguarding in your organization.

- The person selected as a Focal Point should have a genuine interest in the topic of Child Safeguarding, as well as good communication skills;
- Focal Point receives appropriate initial training on the topic of Child Safeguarding and attends complementary training in the field of Child Protection;
- Have in place a job description for the Focal Point, with clear roles and responsibilities.





# STEP 5: COMMUNICATING THE CHILD SAFEGUARDING POLICY TO ALL PARTIES

### <u>WHY?</u>

A Child Safeguarding Policy is only useful as long as it used by all the actors involved in ensuring the safety of children.

- Make sure that all current employees and new staff are aware of your Child Safeguarding Policy;
- Organize child protection and child safeguarding workshops for your staff;
- When recruiting new participants in your activities, communicate your Child Safeguarding Policy beforehand to all children and families that express their interest to collaborate with you.





# STEP 6: EMPOWERING CHILDREN'S VOICES AND THEIR SELF-PROTECTIVE BEHAVIOURS

### <u>WHY?</u>

One of the final goals of any Child Safeguarding Policy is to also empower children to understand the different dimensions of safeguarding and report any concern that they might have.

- Peer-to-peer methodological approach for empowering children's voices (*Resources developed within the project:* "Coloured Shields" manual & childfriendly guide for introducing the concept of safeguarding to children);
- Multiple initial awareness-raising sessions might need to be organized;
- Repeat the process each year for the new children joining your club or summer camp.

# STEP 7: MONITORING THE IMPLEMENTATION OF THE CHILD SAFEGUARDING POLICY

#### <u>WHY?</u>

Adopting a Child Safeguarding policy should not be a one-time initiative, but rather a sustained and long-term organizational commitment.

- Monitor and adjust the Child Safeguarding Policy on a yearly basis:
  - Fill the Self-Assessment Form regarding the stage of implementation of all the Safeguarding measures taken by your organization;
  - Complete the Action and Monitoring Plan which details the concrete steps your organization should take in the next year for improving its safeguarding procedures.





Areas identified in the best practice guide that require further action

- 1. Changing mentalities and attitudes of all staff
- 2. Changing parents` mentalities and attitudes
- 3. Developing and strengthening the collaboration with Child Protection authorities
- 4. Proper allocation of resources and staff for Child Safeguarding
- 5. Engaging in a community of practice in the field of Safeguarding
